

REGISTRATION NOTICE FOR PRESIDENTIAL PRIMARY ELECTION TUESDAY, FEBRUARY 28, 2012

TO THE QUALIFIED ELECTORS:

OF THE

**City of Onaway and the Townships of the
COUNTY OF PRESQUE ISLE, STATE OF MICHIGAN**

PLEASE TAKE NOTICE that a Presidential Primary Election will be held in said City/Township on Tuesday, February 28, 2012. The last day for receiving registrations for the Presidential Primary Election will be Monday, January 30, 2012. Persons residing in the above City/Township registering after 5:00 p.m. on Monday, January 30, 2012 will not be eligible to vote at the Presidential Primary Election. Persons planning to register must determine when the office of the City Clerk or the Township Clerk or the office of the County Clerk or the Secretary of State Branch office will be open for registration in person. Registration may also be made at the specified agency for clients receiving services through the Department of Human Services, the Department of Community Health, Department of Career Development and at the military recruitment offices for persons enlisting in the armed forces. Registration by mail may be used by obtaining and completing a Mail Voter Registration Application and forwarding to the election official as directed on the application by the close of registration deadline. A person who registers to vote by mail is required to vote in person unless they have previously voted in person in the State of Michigan where they live or are at least 60 years of age or are handicapped. Only persons who have registered as electors with the appropriate City Clerk, Township Clerk, County Clerk or through registration at a Secretary of State Branch office or at any specified agency or military recruitment office or by using an official mail registration application, are registered electors of the above City/Township.

PERSONS ENTITLED to be registered voters in said City/Township must possess the following qualifications on or before the day of the Presidential Primary Election: (1) a citizen of the United States; (2) not less than 18 years of age; (3) a resident of the State of Michigan and the local municipality for not less than 30 days prior to the Presidential Primary Election (MCL 168.492). In addition, qualified electors must be registered to vote not less than 30 days prior to the Presidential Primary Election (MCL 168.497).
